USAFL TERMS OF USE POLICY

Welcome to the website for the United States Australian Rules Football League, Inc., a Missouri non-profit corporation (the United States Australian Rules Football League, Inc., together with its subsidiaries, agents and licensors, is collectively referred to as the “USAFL”, and may also be referred to in the Terms of Use Policy as “we,” “us,” or “our”).
